Native leaders press Trump admin, Congress to preserve tribal nations' political status

A coalition of tribal leader councils and Native organizations sent a letter Sunday to President Donald Trump, congressional leaders and Interior Secretary Doug Burgum warning against misclassifying tribal programs as diversity or environmental justice initiatives that could face cuts under recent executive orders.

In the letter, the groups – including organizations representing Native education, health, law, culture and economic development – called on the administration to ensure tribal funding isn't paused or negatively impacted as it implements new executive orders. They emphasized that tribes' relationship with the federal government is based on their status as sovereign political entities, not race.

"Federal tribal programs are not racial or preference programs, and indeed these federal funds and programs are legally mandated under the trust and treaty obligations owed to us," the organizations wrote in the Feb. 2, 2025 letter.

According to the letter, any disruption to tribal

programs would "reverse the progress of the federal-tribal trust relationship over the past 57-year history of the Self-Determination and Self-Governance eras of federal Indian law and policy." "Indian Country is a vital non-discretionary part of the federal government budget," the letter stated, urging the administration to "work towards historic achievements by fully embracing the sovereign status of Tribal Nations to drive unprecedented economic development and prosperity."

The tribal groups expressed willingness to work with the administration on shared priorities, including reducing federal regulations, streamlining funding mechanisms, strengthening tribal self-determination, and addressing long-standing tax issues that impede tribal economic growth.

"Indian Country is a vital non-discretionary part of the federal government budget," the letter stated, urging the administration to "work towards historic achievements by fully embracing the sovereign status of Tribal Nations to drive unprecedented economic development and prosperity."

The groups invited administration officials to discuss these issues at the upcoming NCAI Executive Council Winter Session in Washington, D.C. from February 10-13.

The organizations also cautioned against implementing changes to the federal workforce that could affect the government's ability to fulfill its trust and treaty obligations in Indian Country. They emphasized the importance of maintaining expert tribal offices within each federal agency, which were created through bipartisan efforts to improve federal-tribal relations.

Bad News For the American Indians

American Indian Termination Polices Re-Instated By The Bureau of Labor Statistics (BLS)

Why is the BLS excluding 60% of the American Indian Tribal workers?

This summary is a must read for all American Indian Tribal Leaders. It is nothing short of an EVIL attempt to eliminate the political existences of the American Indian Tribal people.

The Department of Labor is not a big funding source for the Tribes and the majority of the Alaskan Natives and Native Hawaiians. In California for example, which has the largest American Indians & Alaskan Natives population in the Country estimated at 20% of the 5-million. The California Indian Manpower Consortium, Inc., (CIMC) is the primary provider of tribal labor force services in the State.

Since a significant majority of the Tribal Leaders have never heard of the Bureau of Labor Statistics (BLS), where better to test the methodology of manipulating the U.S. Census to reduce the number of American Indian, Alaskan Natives and Native Hawaiians in the National workforce and eventually all the Tribal people in the Nation.

The primary purpose for the bureaucratic policy changes is to justify the Department of Labor REDUCTION OF FUNDS from the American Indian's allocation by 60 percent over a 3-year period beginning with the FY 2024 funds.

The funds are then re-allocated to another budget line item, which is a normal budgetary practice approved the Office of Management & Budgets, (OMB).

However, the "Bait & Switch" strategy by the BLS & DOL was to justify the transfer of 60 percent of the American Indian, Alaskan Natives and Native Hawaiians funds to MIGRANT HOUSING, TRANSPORTATION & OTHER SERVICES.

Again, as stated above, this is only a test, which will eventually be used to eliminate a significant number of American Indian, Alaskan Natives and Native Hawaiians from the U.S. Census and federal funding allocations.

And, for the record this is a WAKE-UP CALL and has little or nothing to do with party politics. For some strange reason the American Indian Leaders & Tribal member think that the political powers that be hold our well-being as a priority. The sad reality is that the majority of Americans could care less. It has been over one year since this started & Tribes have done nothing, why?

My guess is that 95% of the current elected Tribal Leaders under 65-years of age don't know what the American Indian Termination Policy was & this warning will be disregarded. In short it went from genocide, forced simulation through the boarding & reservation schools to the blood quantum of one quarter degree of Indian blood. And even though the American Indian Termination Policy was ended in 1976 many tribes continue to require the blood quantum for tribal membership.

However, I want to share a bit of insight as to how the federal government functions. The ideologies of the Republicans and Democrats has little to nothing to do with the policies and services for the American people including the Indian Tribes. The real political relationship that exist is between the Tribes & the "Deep State," the unelected bureaucrats that actually run the Country.

Once this reality is understood my warning may become clearer. And also please be advised that the "Deep State" is not supportive of Tribal Sovereignty.

As I stated in the text above, the manipulation of the U.S. Census to reduce the number of the American Indian, Alaskan Native and Native Hawaiian and Other Pacific Islander workers to justify the reduction funding for goods and services for them. Some Tribal Leaders pose the argument that the Tribal membership rolls can be used. That is so lame I won't even acknowledge it.

Again, what the Department of Labor is doing is setting the criteria for the eventual elimination of the federal recognition of the American Indian people. It may appear to be trivial, but I assure you that the long term ramification is a serious threat to the tribes.

What is Really Happening:

- BLS BOGUS JUSTIFICATION is pure unprocessed sewage: For different racial categories, we do not disaggregate out Latino or Hispanic ethnicity, consistent with our previous analysis on Native American labor market participation.
- The Census Bureau's "Hispanic or Latino origin" categorization and subcategorizations make it impossible to determine if a given individual is an Indigenous person, a person descended from one of the various European nations that colonized what is today known as Latin America, or a mixture of both, making them inadequate for identifying Indigenous identity.
- The Department of Labor is using the data to justify reduce the funding to Tribal Organizations providing employment training and services to Tribal Members that are part of the reduced Tribal Work Force.
- What Agency is next? 60% of the American Indian and Alaskan Native population of as estimates at 5-million is 3-million leaving 2-million for the Government to appropriate funding.

The claim: Images show Indian migrants who entered the US illegally being deported

A Feb. 5 Facebook post (direct link, archive link) includes photos of handcuffed people walking in a line and sitting in a plane.

"Handcuff & chained Indians," reads text above the images. "Indians who risked their life entering U.S. illegally are being deported back to Anrit Kal (sic)."

The post was shared more than 700 times in two days. Other versions of the claim were shared on Facebook and X.

Our rating: False

The photos show migrants from Mexico, Guatemala, Honduras, El Salvador and Cuba in the process of being deported. They don't show Indian migrants.

Images show Latin American, not Indian, migrants

The Immigration and Customs Enforcement Agency, also known as ICE, launched a wave of raids during the first several weeks of President Donald Trump's second term as part of the administration's crack-down on immigration. The raids resulted in the deportation of more than 100 Indian migrants, according to The Associated Press.

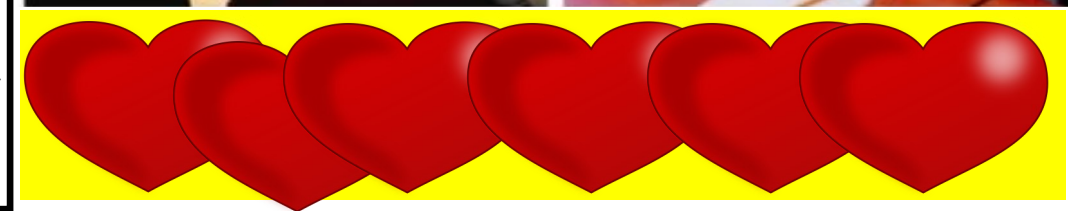

Attorney General Pam Bondi announced Wednesday (Feb. 12, 2025) that New York is being sued by the Justice Department for its efforts to shield illegal immigrants.

"This is a new DOJ and we are taking steps to protect Americans," Bondi said, according to a video posted to social media platform X.

"New York has chosen to prioritize illegal aliens over American citizens. It stops. It stops today," Bondi said.

"As you know, we sued Illinois and New York didn't listen, so now you're next," she said, according to Spectrum News.

"If you don't comply with federal law, we will hold you accountable," Bondi said. *"We did it to Illinois, strike one. Strike two is New York. And if you are a state not complying with federal law, you're next. Get ready,"* according to Fox News.

Bondi announced that the lawsuit is targeting Democratic Gov. Kathy Hochul, Attorney General Letitia James, and Mark Schroeder, the state commissioner of the Department of Motor Vehicles, according to USA Today.

US Treasury made \$100-BILLION payment to individuals without SS or ID — Elon Musk

Elon Musk, leader of the Department of Government Efficiency, said he was told that there is about a \$100 billion annual payment of entitlements to individuals without a Social Security Number or even a temporary identity number.

Musk made this known in a statement through his X account on Saturday, clarifying what DOGE Team and US Treasury have jointly agreed on in the past few days.

Explaining DOGE's efforts at the Treasury Department, Musk said, "Yesterday (Friday, Feb. 7, 2025), I was told that there are currently over \$100 billion per year of entitlement payments to individuals with no SSN or even a temporary ID number. If accurate, this is extremely suspicious.

"When I asked if anyone at Treasury had a rough guess for what percentage of that number is unequivocal and obvious fraud, the consensus in the room was about half, so \$50 billion per year or \$1 billion per week!"

"This is utterly insane and must be addressed immediately," he stated.

This comes as a DOGE is pushing for access to US Treasury Department payment records.

As of the earlier hours of Saturday, (Feb. 8, 2025) US District Judge Paul Engelmayer blocked DOGE from accessing the personal financial data of millions of Americans in Treasury Department records.

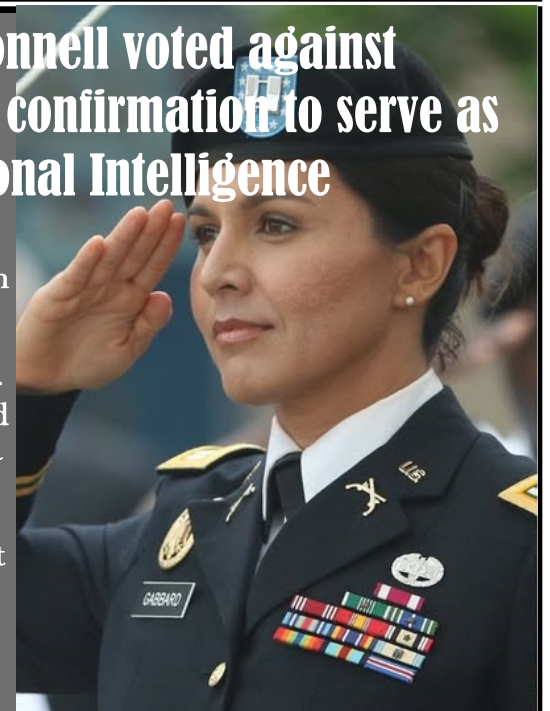

Why some are lashing out at the Super Bowl's pre-game ceremony

More than a century after the NAACP adopted "Lift Every Voice and Sing" as the "Black national anthem," the song has sparked social media-fueled backlash in the lead-up to Sunday's Super Bowl in New Orleans.

"The performance of the song should be framed to the public not as a protest song but as a song of Black affirmation, perseverance and inspira-

tion," said Gerald Early, the pop culture essayist who teaches in the African and African American studies department of Washington University in St. Louis. "It is unfortunate that the song's performance has become a culture war issue."

Early said people's response to the Black national anthem is similar to criticism of Kaepernick a decade ago.

"Some who are opposed to Lift Every Voice and Sing' think of it as another protest or as a protest song and couple it with Kaepernick's protest," he said. They are, more than likely, "sick of protests associated with American sports and American entertainment generally."

bia [Ed Martin](#) sent a letter one day after Trump retook office asking Schumer about those remarks.

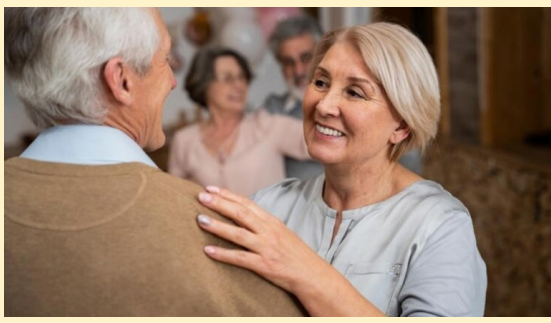
