Deadbeat Newscum passes loan cost off to California businesses

We may never run out of signs that Gov. Gavin Newsom (D-CA) is an utterly incompetent executive who belongs nowhere near power. The latest is that he has not repaid a federal pandemic unemployment loan, effectively creating a new California tax on jobs.

During the 2020 pandemic, the Trump administration provided loans to states to help address unemployment as businesses were shut down. California received a loan of \$20 billion and, more than five years later, has not paid it back. In fact, California is one of only two states that have not repaid their loans. And California failed to do this despite the Biden administration giving all states the ability to repay loans with federal stimulus money.

This means the cost is now passed on to California employers. Every employer in California will be required to pay an additional \$42 per employee in payroll taxes to help the state pay back the loan. That will increase by \$21 every year until the loan is paid back (which is not projected to happen until the 2030s). It does not matter if the employee is part-

time or full-time. It does not matter if the employer is a big business or a small, family-run store. Everyone will be taxed for each person they employ.

That means, in effect, Newsom and California Democrats have allowed a new tax on employing people to take effect while having the highest unemployment rate of any state in the country. California, with onerous regulations and taxes, already makes job growth difficult; in 2024, 96.5% of new jobs created were government jobs. This will only make it even more difficult, all because Newsom and California Democrats want to recklessly spend money without making sure everything is paid for.

California's latest budget deficit estimate for the upcoming fiscal year has increased by another \$5 billion, to \$18 billion. It is estimated to grow to \$35 billion the following year. Newsom and California Democrats continue to tax residents into the dirt and still can't manage the state's finances, resorting to kicking the can down the road and hoping they can be terminated out of office in time for this to be a problem



for the Democrats who replace them in the governor's mansion and the state legislature.

No one in American politics has more unearned arrogance than Newsom right now. He continues to lecture everyone about how things can be run while he has failed California in every area of governance. This is the latest example, but it won't be the last, given that Newsom is more focused on fluffing his ego and running for president than he is on running the largest state in the country.

DHS says new Illinois law violates Supremacy Clause

Illinois Gov. JB Pritzker has signed House Bill 1312, expanding protections against federal immigration enforcement. Critics argued the move conflicts with federal law and could hinder the detention of illegal immigrants with criminal convictions. Analysts noted the bill will likely face legal challenges.

Illinois noted that HB 1312 specifically limits state cooperation with federal enforcement. DHS urged honoring ICE detainers for 4,000+ inmates, calling the law a Supremacy Clause violation.

Pritzker said, *"With my signature today, we are protecting people and institutions that belong here in Illinois. Dropping your kid off at day care, going to the doctor, or attending your classes should not be a life-altering task."*

Pritzker added, *"Illinois — in the face of cruelty and intimidation — has chosen solidarity and support. Donald Trump, Kristi Noem, and Gregory Bovino have tried to appeal to our lesser instincts. But the best of us are standing up to the worst of them."*

White House spokeswoman Abigail Jackson said, *"Cracking down on crime and deporting dangerous criminal illegal aliens should not be a partisan issue, but Democrats suffering from TDS are trying to make it one, all at the expense of the Americans they are elected to serve."*

Kim Varet, a former art dealer turned congressional candidate, has frequently levied racist attacks at Republicans during her campaign to unseat California Rep. Young Kim.

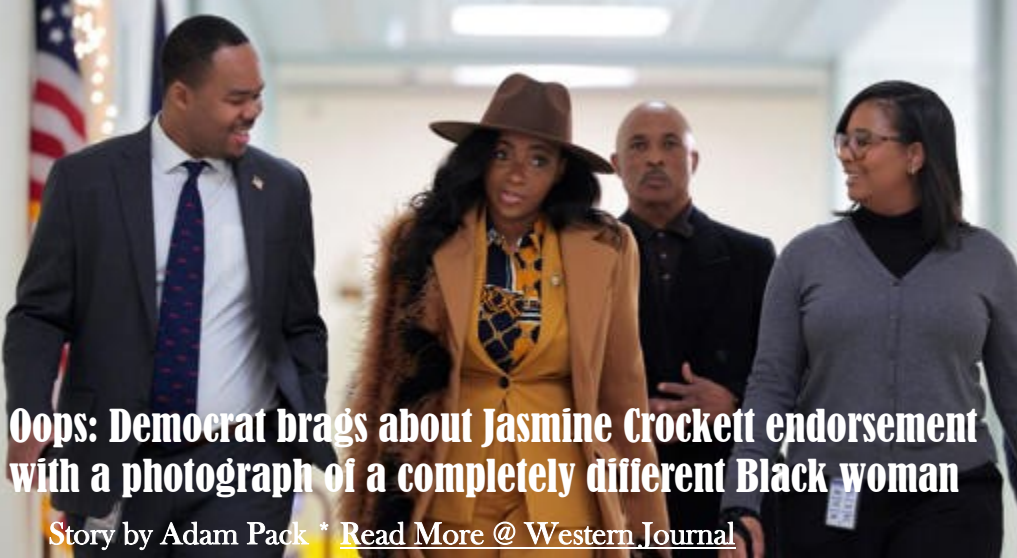
Business Insider first reported Thursday that Kim Varet's website used a photo of a black woman who is not Crockett to highlight the alleged endorsement.

A spokesperson for Kim Varet did not immediately respond to the Daily Caller News Foundation's request for comment.

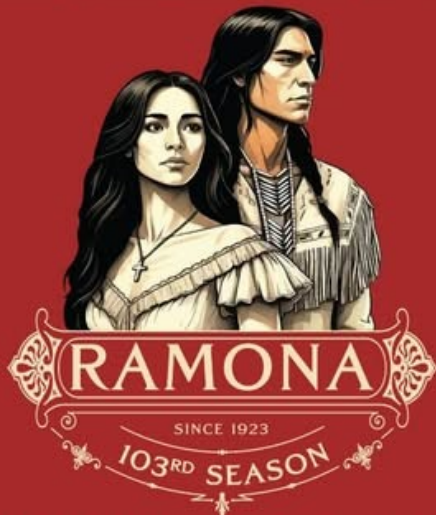

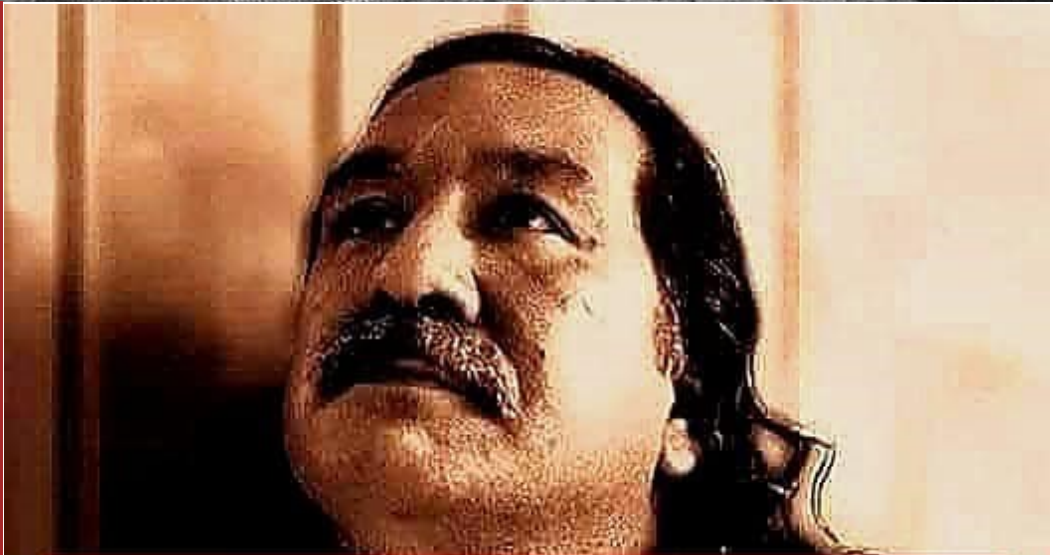

Nanye-Hi, known as the "War Woman," was a fierce leader and a symbol of bravery and determination. 'Minority serving institutions' are unconstitutional, DOJ says

Education Department programs that reward colleges for meeting racial quotas are unconstitutional, the U.S. Department of Justice’s Office of Legal Counsel concluded this month.

The opinion came from a request by the Dept. of Ed. to review the legality of federal programs that “distinguish between beneficiaries based on race” in light of the *Students for Fair Admissions* Supreme Court decision.

“Many of these programs restrict award eligibility to educational institutions whose student bodies reflect a particular racial composition,” the DOJ report states. *“The Developing Hispanic-Serving Institutions program, for instance, is open only to educational institutions whose student bodies are 25 percent Hispanic or more.”*

The report also names the “Alaskan Native and Native Hawaiian-Serving institutions” as similarly problematic programs.

It also identifies other grants, including the “Ronald E. McNair Postbaccalaureate Achievement program,” which favors non-white students.

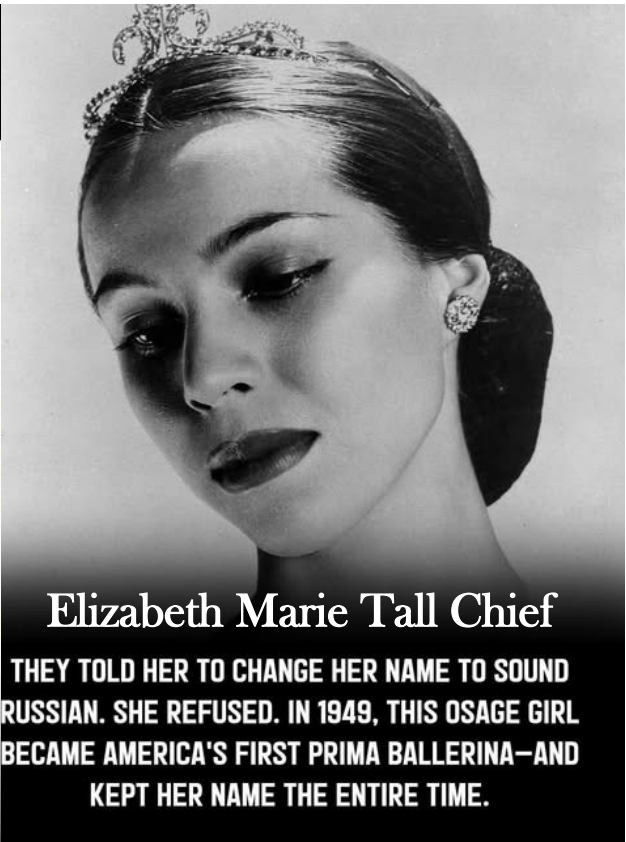
This program can stand, but it must have “new, race-neutral regulations to facilitate federal financial support to institutions of higher education for projects covered by the statute,” the DOJ report stated. However, the program “must not consider—directly or indirectly—the race or ethnicity of project participants.”

Chief Victoriona died in August 1888 at the age of 132. The chief, representing the Sobobas, signed a peace treaty at Temecula in 1852. The Soboba Reservation was formed in 1883, but land developers were still intruding on Native American land. In the early 1880s, Helen Hunt Jackson was in the valley researching the plight of the Native Americans for her book *Ramona*. She was appointed by the government to intervene on behalf of the tribe and was ultimately able to secure the Soboba land. (Courtesy San Jacinto Museum.)



Although transportation by Soboba families was mostly achieved via horseback or foot during the 1880s, some families were fortunate enough to incorporate a horse-drawn buggy. The Soboba Indian Reservation is situated at the east end of Main Street in San Jacinto and on the northeast side of the San Jacinto River; from there, tribe members traveled in order to barter and secure food. Americans oppose \$2,600 tax increase for Social Security as program faces collapse

Countless Americans rely on Social Security benefits to cover essential living expenses, but federal authorities are expressing alarm that payments could face severe cuts unless immediate action is taken.

While Social Security recipients are set to receive an increase next year through the 2026 cost-of-living adjustment (COLA), financial experts are raising red flags about payments exceeding available funding. This imbalance threatens to push Social Security toward insolvency, potentially leaving insufficient resources for future benefit distributions.

Multiple strategies have been proposed to address this looming crisis. The Committee for a Responsible

Federal Budget revealed in a November report that limiting COLA increases for wealthy recipients could generate \$115 billion in savings over ten years.

An alternative approach involves increasing taxes designated for the program. However, research conducted by the Cato Institute and YouGov revealed widespread resistance to tax hikes, even among those who view Social Security as an essential government service.

Survey results showed 70% of participants expect benefit reductions in coming years, while 30% predict the program will completely disappear before their retirement.

Public sentiment toward the program remains favorable (with 83% approval among respondents), yet Americans remain divided on potential solutions.

Is Social Security facing financial collapse?

According to the Committee for a Responsible Federal Budget analysis, the organization warned, "The retirement trust fund is seven years from exhaustion, and the theoretically combined trust funds are nine years from running out.

"Without legislative action, retirees will face an estimated 24 percent across-the-board benefit cut in late 2032."

The IRS quietly released new tax brackets for 2026 Some Americans will save thousands while others won't be so lucky. What about you?

Amid October headlines about the government shutdown, the IRS made a significant announcement without much fanfare: new tax brackets that will impact every taxpayer in the country (1).

Changes to brackets aren't new. They're adjusted upwards every year to account for inflation, using the Consumer Price Index (CPI) as a guide.

This can be helpful if your wages are just keeping up with inflation. But this year, the adjustment's announcement didn't seem to be big news.

Perhaps because the bump in tax brackets isn't big, either.

Here's more on the tax bracket updates and what they could mean for you.

This year's bump was modest, relatively speaking.

For individual filers, these are the new income tax brackets (3):

- 10% tax bracket: \$0-\$12,400
- 12% tax bracket: \$12,401-\$50,400
- 22% tax bracket: \$50,401-\$105,700
- 24% tax bracket: \$105,701-\$201,775
- 32% tax bracket: \$201,776-\$256,225
- 35% tax bracket: \$256,225-\$640,600
- 37% tax bracket: \$640,601 and up

The upper end of the lowest tax bracket (10%) has been raised from \$11,925 in 2025 to \$12,400 in 2026. That's a 3.9% increase.

Meanwhile, the income threshold for the top marginal tax rate (37%) has been raised from \$626,351 to \$640,601 for individual tax filers next year. That's a smaller bump of 2.3%.

Swalwell lawsuit sparks political firestorm

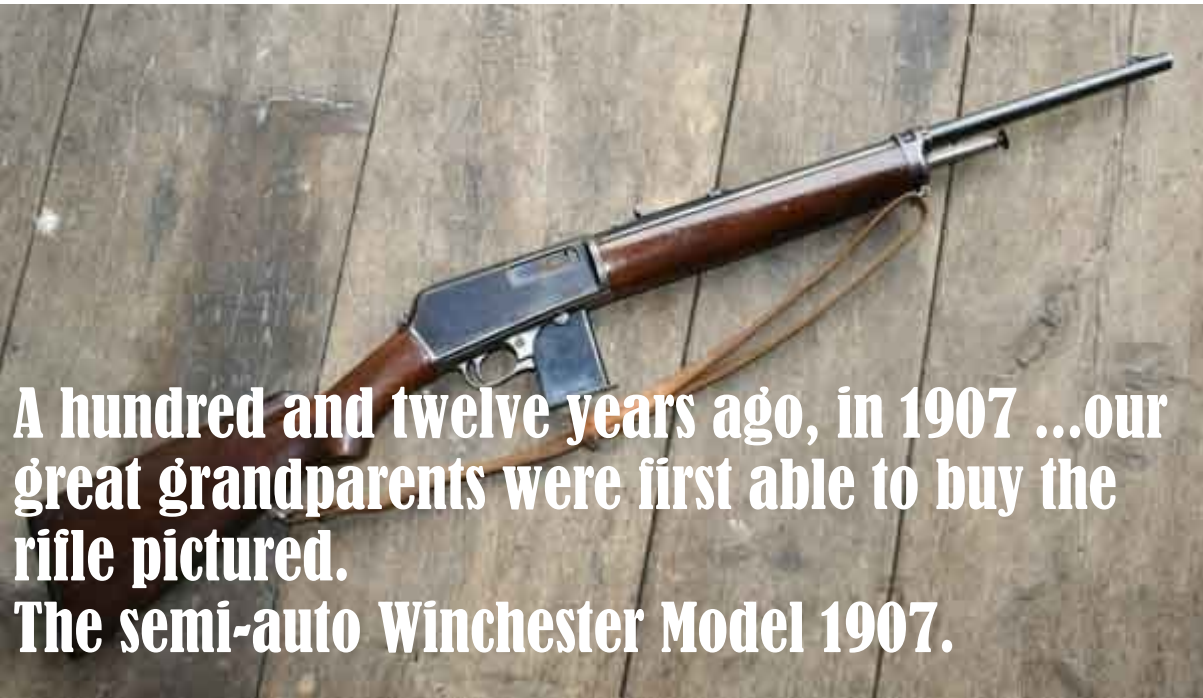
Rep. Eric Swalwell (D-CA) has filed a lawsuit against Federal Housing Finance Agency Director Bill Pulte for allegedly accessing mortgage records to falsely accuse several Democrats of fraud. Swalwell is seeking a court order to withdraw a Department of Justice (DOJ) referral that alleges mortgage fraud against him, claiming the referral is the result of pressure from President Donald Trump. Pulte alleged Swalwell misrepresented his residence on loan documents, which he denies.

Swalwell wrote that Pulte has played “an integral role in supporting President

Trump’s campaign of retribution against his political foes.”

Swalwell wrote, “Pulte’s brazen practice of obtaining confidential mortgage records from Fannie Mae and/or Freddie Mac and then using them as a basis for referring individual homeowners to DOJ for prosecution is unprecedented and unlawful.”

The case docket shows defendants have been served, and counsel appearances are in place. The court set a deadline of March 4, 2026, for FHFA/Pulte to file an answer or response to Swalwell’s complaint.

after civilians had them.

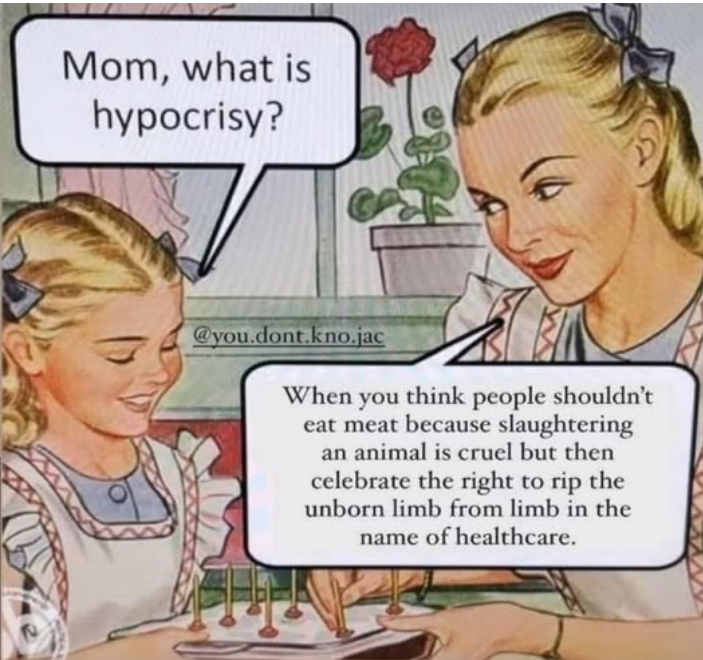

FBI Director Kash Patel praised agents in Illinois on Tuesday for arresting over 60 individuals in just one week, as part of the Justice Department’s Operation Safe Christmas. During the operation, 63 criminal offenders were apprehended, along with the seizure of 2.5 pounds of narcotics and \$15,000 in cash.

The mission was conducted in the Southern District of Illinois and was a collaborative effort involving the FBI, the Department of Justice, the U.S. Marshals Service, the Illinois State Police, the ATF Chicago, and the Drug Enforcement Administration, according to Just the News.

“Great work [FBI Springfield] and partners,” Patel noted on X. *“60+ arrests in just 7 days and American streets safer because of it. FBI continues to have a historic year coordinating with LEO’s across the country and cracking down on crime.”*

The arrests were linked to a larger nationwide law enforcement effort aimed at combating violent crime and drug distribution.

“Operations like this reflect the strength that comes from close cooperation among law enforcement agencies,” FBI Springfield Special Agent in Charge Christopher Johnson said. *“By working together, we are able to locate and apprehend individuals who drive violent crime into our communities.”*

“The successful arrests made during this sweep represent FBI Springfield’s continued commitment to crushing violent crime and keeping our neighborhoods safe,” he added.

Federal authorities, meanwhile, announced earlier this week that they disrupted a credible terrorist threat over the weekend by arresting four alleged members of a radical pro-Palestinian extremist group. These individuals are accused of planning coordinated bombings in Los Angeles on New Year’s Eve.

The FBI told Fox News Digital that the suspects identified themselves as part of a radical offshoot of the Turtle Island Liberation Front (TILF), a group driven by pro-Palestinian, anti-law enforcement, and anti-government ideologies.

According to the FBI, the suspects allegedly intended to carry out coordinated bombing attacks using improvised explosive devices, targeting five different locations throughout Los Angeles.

The agency reported that four individuals were arrested in Lucerne Valley, where they were suspected of preparing to test explosive devices in advance of planned attacks. Each person has been charged with conspiracy and possession of a destructive device.

On Monday, the FBI announced the arrest of a fifth individual in New Orleans, who is believed to be connected to the same TILF extremist group and is accused of planning a separate attack.

According to an Instagram account associated with TILF, their founding chapter is located in Los Angeles, and their objective is to liberate “Turtle Island,” an Indigenous term referring to North America, from what they describe as the “illegal American empire.”

“Free Palestine. Free Hawaii. Free Puerto Rico,” the account posted. “Freeing the world from American imperialism is the only way to a safe and peaceful future.”

Attorney General Pam Bondi announced on X that the Department of Justice collaborated with the FBI to thwart an alleged terror plot in the Central District of California. She noted further that the group planned to target ICE agents and vehicles.

“This was an incredible effort by our U.S. Attorneys’ Offices and the FBI to ensure Americans can live in peace,” Bondi wrote. *“We will continue to pursue these terror groups and bring them to justice.”*

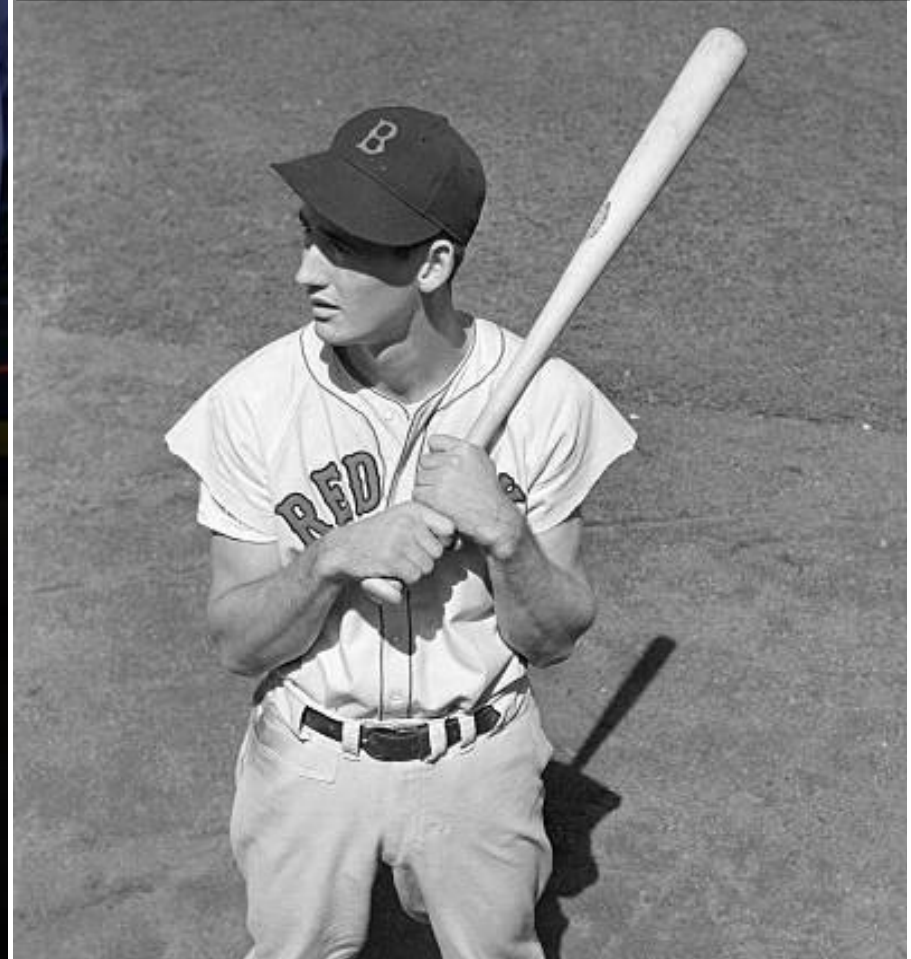

December 29, 2025 marks the 135rd anniversary of the **Wounded Knee Massacre** on the Pine Ridge Indian Reservation, South Dakota in 1890.

Time should not diminish its memory, as it was only one of numerous acts of terrorism and genocide committed against our people.

Just as we celebrate Christmas in honor of the birth of our Lord and Savior, Jesus Christ (*At least for many of us believers and not so politically correct folks*) and with the New Year right around the corner let us take a moment to remember and honor our people murdered at **Wounded Knee, South Dakota**.

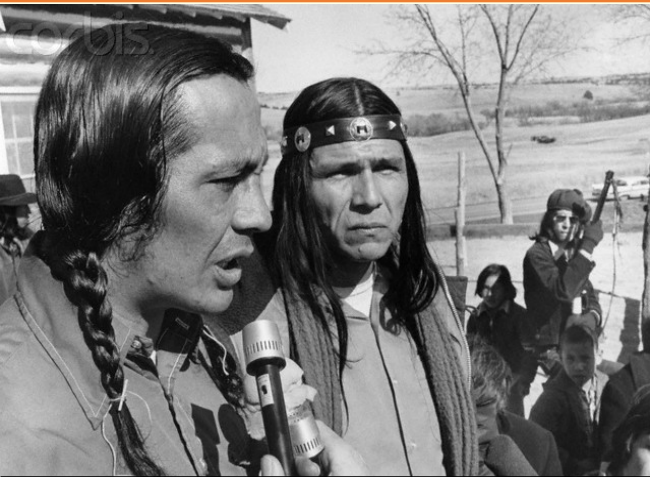
On that infamous day, December 29, 1890 it is estimated that 275 Lakota Sioux men, women and children were murdered with hundreds more wounded and 25 U.S. soldiers killed and for no other reason than fear! **Fear of the "Ghost Dance"** was the reason given as if one could justify the incomprehensible murdering and maiming of so many innocent people. Why, because of the political policies at that period in time.

After all what more could the "Indians" want? The Government was going to take care of them as long as the rivers flow and the grass shall grow.

Again, 52-years ago on February 27, 1973, **Wounded Knee**, South Dakota became the center of national attention when the **American Indian Movement (AIM)** leaders, Denis Banks and Russel Means led an armed takeover and occupation of Wounded Knee.

The protest followed the failure of an effort of the Oglala Sioux Civil Rights Organization (OSCRO) to impeach tribal president Richard Wilson, whom they accused of corruption.

The armed occupancy of **Wounded Knee** which received national attention, ended after 71 days when **Lawrence "Buddy" Lamont**, a local Oglala Lakota, was killed by a shot from a

government sniper on April 26, 1973. He was buried on the site in a Sioux ceremony. A U.S. marshal was also shot and paralyzed.

After Lamont's death, tribal elders called an end to the occupation. Knowing the young man and his mother from the reservation, many Oglala were greatly sorrowed by his death. **Both sides reached an agreement on May 5, 1973 to disarm.**

Over 200 federal armed law enforcement were joined by local law enforcement and Wilson's private militia, *Guardians of the Oglala Nation* (GOONS).

With the decision made to end the protest, many Oglala Lakota began to leave Wounded Knee under the cover of darkness walking out through the federal agents lines.

Three days later, the siege ended and the town was evacuated after 71 days of occupation; Government agents took control of the town.

The stand at **Wounded Knee** electrified American Indians, who were inspired by the sight of their people standing in defiance of the government which had so often mistreated them.

Many American Indian supporters traveled to **Wounded Knee** to join the protest. At the time there was widespread public sympathy for the goals of the occupation, as Americans were becoming more aware of longstanding issues of injustice related to American Indians.

AIM leaders Dennis Banks and Russell Means were indicted on charges related to the events, but their case was dismissed by the federal court for prosecutorial misconduct, and upheld on appeal.

With the support of the U.S. Government, Wilson stayed in office and in 1974 was re-elected amid charges of intimidation, voter fraud, and other abuses.

The rate of violence climbed on the reservation as conflict opened between the political factions during the following three years; *More than 60 opponents of Wilson's tribal government died violently during those years*, including Pedro Bissonette, director of the Oglala Sioux Civil Rights Organization. Traditional tribal members blamed Wilson's private militia, **Guardians of the Oglala Nation (GOONS)**.

Shortly following the **Wounded Knee** standoff 21-year old **Leonard Peltier**, a young AIM leader was asked by traditional Indian people at Pine Ridge, to help protect them from being targeted for violence by Wilson's tribal GOONS. He went to their aid never to return home to his wife and children.

On June 26, 1975 two FBI agents in unmarked cars followed a pick-up truck onto the Jumping Bull ranch. The families immediately became alarmed and feared an attack. Shots were fired and a shoot-out ensued. **More than 150 federal agents, GOONS, and law enforcement officers surrounded the ranch occupied by 40 traditional Indians.**

When the shoot-out ended FBI Special Agents, Jack R. Coler and Ronald A. Williams and American Indian, Joseph Stuntz lay dead. Stuntz's death has never been investigated, nor has anyone ever been charged in connection with his death.

Leonard Peltier was convicted for the deaths of the two FBI agents killed

during the shoot-out on the Pine Ridge Indian Reservation.

He was sentenced to life in prison where he remained for over 50 years until he was pardoned by President Biden on January 20, 2025.

However, concerns have been expressed over his pardon because it was done by "Auto-Pen."



Yet, 60 Oglala Sioux died at the hands of the **GOONS** after that infamous day and no one was ever investigated, charged or prosecuted. **The FBI and GOONS prevailed.**

Numerous doubts have been raised over Peltier's guilt and the fairness of his trial, based on allegations and inconsistencies regarding the FBI and prosecution's handling of this case.

Even former U.S. Attorney General, **Ramsey Clark** served *pro bono* as one of Peltier's lawyers and has aided in filing a series of appeals on Peltier's behalf. In all appeals, the conviction and sentence have been affirmed by the 8th Circuit Court of Appeals.

The sad irony is that 135-years after the December 29, 1890 **Wounded Knee Massacre** and 52-years since the 1973 armed protect on the Pine Ridge Indian Reservation, South Dakota very little has changed for the American Indians.

However, progress is being made as more tribes are getting involved in the political process but **government dependency is a hard nut to break.**

Ghost Dance Founder. Wovoka (AKA Jack Wilson)

Wovoka (AKA Jack Wilson) was born in Smith Valley area southeast of Carson City, Nevada, around the year 1856. **Quoitze Ow** was his birth name.

From the age of eight until almost thirty he worked for a rancherin in the Yerington, Nevada area, David Wilson and his wife Abigail, who gave him the name Jack Wilson for when dealing with European Americans.

David Wilson and his wife were devout Christian, and Wovoka learned Christian theology and Bible stories while living with the Wilson's.

One of his chief sources of authority among Paiutes was his alleged ability to control the weather. He was said

to have caused a block of ice to fall out of the sky on a summer day, to be able to end drought with rain or snow, to light his pipe with the sun, and to form icicles in his hands.



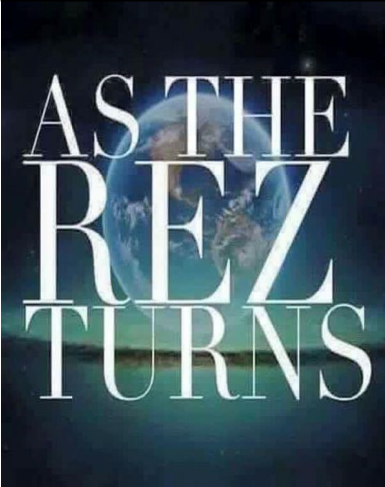
Wovoka claimed to have had a prophetic vision during the solar eclipse on January 1, 1889. His vision entailed the resurrection of the Paiute dead and the removal of whites and their works from North America. He taught that in order to bring this vision to pass the American Indians must live righteously and perform a traditional round dance, known as the "**Ghost Dance**", in a series of five-day gatherings. His teachings spread quickly among many American Indian peoples, notably the Lakota.

The **Ghost Dance** movement is known for being practiced by the victims of the **Wounded Knee Massacre**; Indian Agents, soldiers, and other federal officials were predis-

posed towards a militaristic posture when dealing with a movement that was so antithetical to their views and ideas.

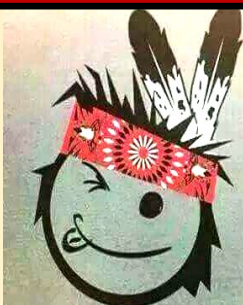
Wovoka's preaching's included messages of non-violence, but two Miniconjou, Short Bull and Kicking Bear, allegedly emphasized the possible elimination of whites which contributed to the existing defensive attitude of the federal officials who were already fearful due to the unfamiliar "**Ghost Dance**" movement.

Wovoka died in Yerington on September 20, 1932 and is interred in the Paiute Cemetery in the town of Schurz, Nevada.

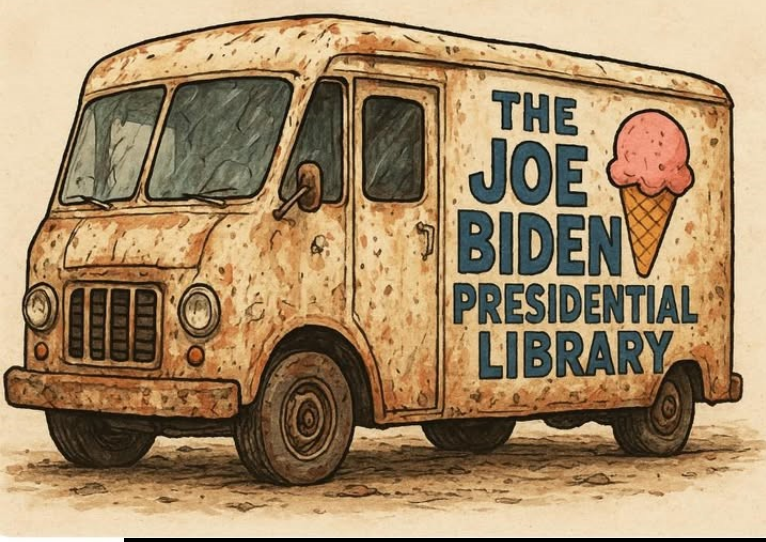
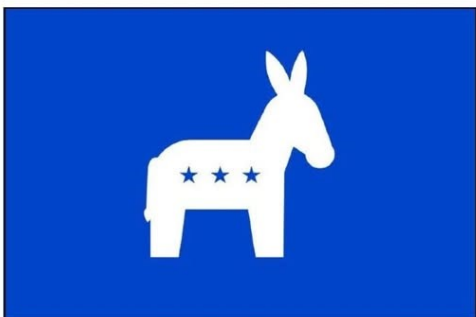
